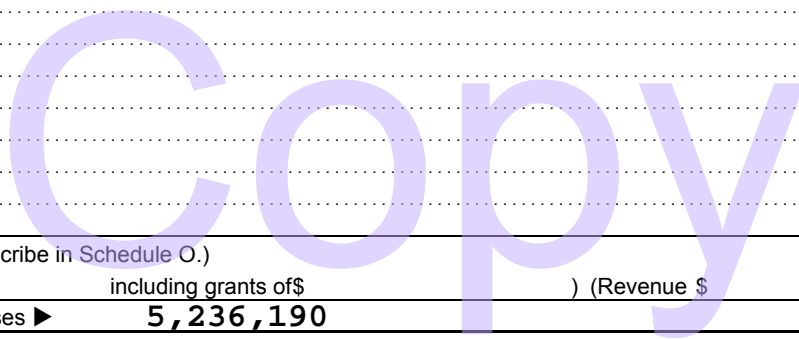

In 2012-13, we provided over 1,677 families and 4552 individuals with financial assistance and in-kind donations primarily consisting of food distribution, household items, and holiday gifts. We also provided over 38,926 families and over 98,132 individuals with food. (Duplicated number as people are counted each time they pick up food per funder requirements.) Also, information and referrals, and budget assistance services were provided.

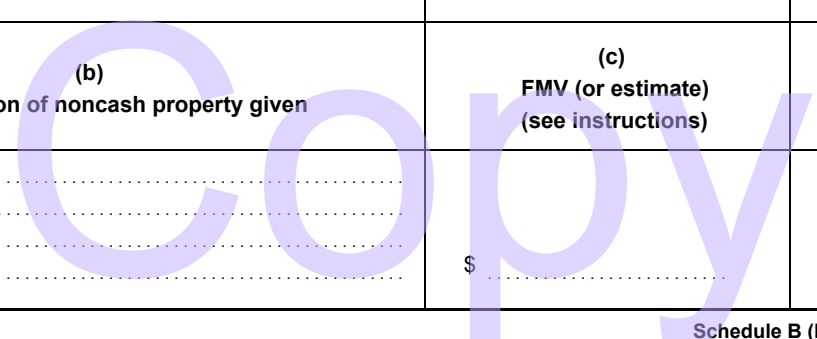

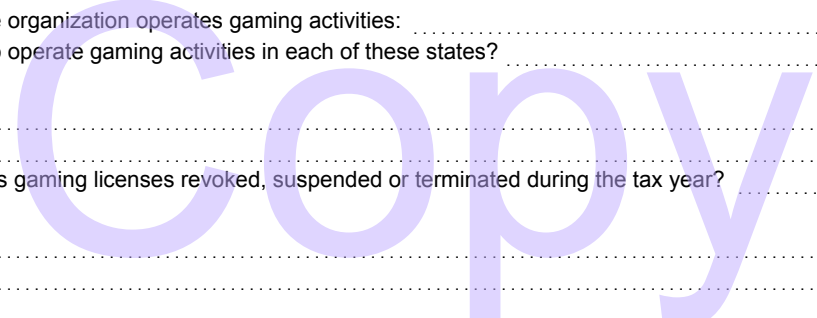

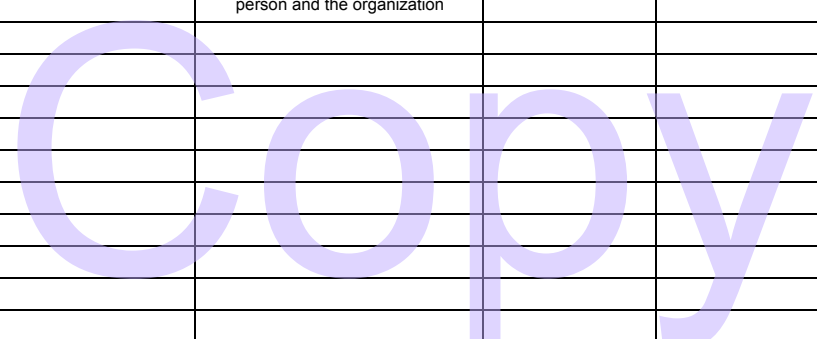
