## Director's Message: ENTER OUR CONTEST— WHAT COMES AFTER “EXPLODING”?

Every year for the past four years, I've written about the sharply increasing level of need we're seeing at SCS. In 2004-05, we said that need was dramatically increasing, then growing phenomenally, then skyrocketing, and last year, exploding. What we're seeing now makes all past levels of need and descriptions pale in comparison. So we are conducting a contest. What word(s) can we use—and print—to describe what comes after “exploding”? Send in the winning description, and win a gift package of practical SCS items.

We don't intend in any way to be flippant or glib about the serious financial problems facing so many low-income Sunnyvale families and seniors. Too many have lost their jobs, even both breadwinners in the family. Too many face eviction or utility disconnections. Others need health care, have no insurance, and can't afford insurance, medical care, or prescriptions. And we are only just beginning to see more formerly middle class families affected by the economy who are facing the same problems as our low-income clients. However, they had more resources that they exhausted or families and friends able to help them for a while before they sought our help.

Four years ago, we spent \$390,000 on financial aid; last fiscal year, \$610,000. This year, we spent that much before the end of March. Four years ago, we gave out in-kind aid, primarily food, valued at \$660,000; last year, \$1,335,000. We will certainly exceed that amount this year as we are giving food to over 1,400 families each month (compared to 750 four years ago). We are doing everything possible to raise funds in order to help all clients eligible for assistance. Last year, we didn't turn anyone away because we lacked the resources to help them, but we did so by the skin of our teeth, ending the year after \$2.7 million of expenses with a surplus of \$5,750. For our clients, your support quite literally means a roof over their heads, healthy living conditions, food on the table, and access to basic medical care. We ask you to donate whatever you can because, more than ever, every little bit truly helps.

## TONY'S TRIBUTE



Each year at the annual Sunnyvale Chamber of Commerce Murphy Awards dinner, SCS honors a Volunteer of the Year. This year's honoree was **Anthony Thiebaud**. Tony is one of our Chief Food Officers (CFOs), moving tons of food, packing, and distributing for the monthly food programs for families and seniors. He spends the entire month of December at the Community Christmas Center, picks up food each month at the Sunnyvale Presbyterian Church, and makes many other pickups and deliveries. And in February, March, and April, he spends two days a week as an AARP Foundation volunteer tax preparer at SCS.

and if you can't, you'll usually end up paying more.

- Recently, a man in his late 70s came to SCS for help with a dental bill. Medicare doesn't cover dental work, and he couldn't afford any supplemental plans. So he had pulled his own tooth out. That led to an infection and a dental bill more expensive than an extraction would have been. A good neighbor learned that the man had been going without food to accumulate funds to pay for the dental work. She brought him to SCS. We paid the bill and signed him up for our on-going food program.
- An SCS staff member needed a minor auto repair and went to a small shop in a Sunnyvale strip mall. The customer ahead of her needed major engine work (over \$1,400). He hadn't been able to pay for routine maintenance for almost two years, so the resulting cost was much higher. He worked out a payment plan with the owner. Because his business had dropped off significantly, the owner had laid off two of his four employees and, in a conversation with the staff member, said that his wife had been coming to SCS for food for the past four months.
- A single mother did not take her child to the doctor when she had a persistent but seemingly mild cough. The mother's low-paying job provided no benefits including paid sick leave, and she barely made ends meet each month. Taking time off work for a medical appointment (taking the bus and waiting several hours at a public clinic) meant at least four hours lost wages. By the time the child did see the doctor, she developed complications from bronchitis, and the mother had to stay home for several days with the child. She came to SCS for help with her PG&E bill which she couldn't pay due to the lost wages.

## CHINESE SENIORS CLUB VOLUNTEERS ARE A STAPLE AT SCS



Preparing our newsletter for mailing would cost us more than printing it. Twice a year, volunteers from the Chinese Seniors Club insert the flyers and envelopes, staple, attach labels, and sort 12,500 copies by zip codes required for bulk mailing. And they do it all in one day.

SCS has sponsored the club for over 30 years. The club offers English and citizenship classes, instrumental and choral music activities, traditional Chinese and ballroom dancing, Tai Chi, a variety of art activities, and educational seminars on healthcare issues. It holds three luncheons a year with performances by costumed singers and dancers. In addition, club volunteers also help with SCS food distribution programs. Our sincerest thanks to all Chinese Seniors Club volunteers.

## COMMUNITY CHRISTMAS CENTER 2008: THE GLASS WAS HALF FULL, HALF EMPTY, AND OVERFLOWING



At the risk of sounding like a broken record, the 2008 Community Christmas Center helped a record number of people and distributed record amounts of food and gifts. **1,280 families (4,120 people)** selected a two-week supply of food, new gifts for infants through teens, and a practical household gift, 114 more families and 481 more people than in 2007. To supplement community and Food Bank donations for Thanksgiving and the holidays, we purchased, at substantial discounts, \$102,000 of food, \$40,000 more than the prior year. In addition, thanks to the efforts of the **Northwest YMCA**, the **Sunnyvale Rotary Club**, and other donors, each family was able to select two warm coats, cleaned and delivered to the center by the YMCA.

These accomplishments were possible despite the fact that 2008 was the first time in several decades that less food and fewer gifts were donated during the holidays. Many companies had downsized; some moved out of Sunnyvale. In several cases, firms laid off corporate community relations staff who organized company-wide food and gift drives. However, thanks to increased donations, we were able to buy more food. Thanks to donors who took advantage of sales throughout the year, we had enough gifts, though barely.

**640 volunteers donated 4,384 hours** to make this program such a success, from “moving in and decorating weekend” to the last day of distribution and removing all traces of the Christmas Center, returning the building to what passes as normal. Because the Christmas Center is so difficult to describe, **Jeanne Yeager**, an SCS caseworker whose family also produces **“On the Move,”** a cable access weekly TV show on all aspects of disabilities, asked **Gordon Peterson**, a volunteer with the show, to film the Christmas Center. **SILICON VALLEY community® foundation**  
SERVING SAN MATEO AND SANTA CLARA COUNTIES

Last summer, the Silicon Valley Community Foundation convened a series of focus groups in order to determine its funding priorities. In September, it held a regional meeting to announce five grantmaking priorities. The foundation allocated \$3 million for Safety Net Services, the first area funded. In the middle of December, SCS received \$75,000. Less than one month later, we asked for the final report form, having spent \$25,000 on food for the 4,120 people helped by the Community Christmas Center and \$50,000 to prevent eviction for 49 families. Both the foundation and we were surprised how fast we spent the grant funds. As soon as the report form was developed, we sent in our final report with sincerest thanks for the very timely and generous grant.

**El Camino Hospital**  
THE HOSPITAL OF SILICON VALLEY

El Camino Hospital is committed not only to the health of its patient population but also to the health of the broader community, especially the most vulnerable community members. This past year the hospital Board of Directors decided to formalize this commitment by establishing set funding for the hospital’s community benefit investment thereby allowing for long term planning and support of local organizations. SCS received \$50,000 to pay medically-related expenses for low-income clients or to pay rent if they had already paid hospital, medical, or prescription bills and didn’t have enough left for rent. We paid bills for 33 families and bought 11,000 quarts of powdered milk for our holiday programs.



The support of Principal **Genie Florczyk** and Vice Principal **Diane Tyler** has been the key to the successful food and gift drives for many years by the students at St. Martin School in Sunnyvale.



Members of **St. Mark Lutheran Church** have been among our most supportive volunteers as well as among the most generous. Members of the congregation contribute over \$5,000 a year, donate food year round, and bring gifts for the Community Christmas Center.



For 25 years, **Cindy McCown** has been a most valuable asset of Second Harvest Food Bank. Thanks to her, agencies have more food, new freezers and refrigerators, delivery service, and fresh produce.

### YOU MEAN THAT THERE'S POVERTY IN SUNNYVALE?

People don't usually associate Sunnyvale with poverty or people in need, but, sadly, they should.

- United Way Silicon Valley has identified Sunnyvale as one of the two fastest growing poverty areas in Santa Clara County. (The other is Milpitas.)
- The City's 2005-2010 Consolidated Plan shows that 27.3% of its population falls equally into extremely low, very low, and low income categories.
- That same City plan shows that seniors are by far the largest group of Sunnyvale residents in each of the three low income categories.
- Second Harvest Food Bank identified one Sunnyvale zip code (since divided into two) as among the 10 neediest in the county in terms of the number of people experiencing hunger or "food insecurity" (not having enough food throughout the month).
- 47% of students in the Sunnyvale School District qualify for free and reduced price meals. Income guidelines for a family of four are \$27,560 a year or less for free meals and \$27,561 to \$39,220 a year for reduced price meals.

## GOAL!

Last year, the **Sobrato Family Foundation** awarded SCS a \$40,000 challenge grant. If we could

raise that much in new and increased donations as well as donations from those who hadn't given in the past 12 months, we would receive another \$42,000, the match allowance plus a 5% cost of living increase. Thanks to your generous contributions, we reached and exceeded the \$40,000 required, even in a challenging economic year. Our sincerest thanks to all of you who helped us achieve the challenge and to the Sobrato Family Foundation for its generous support.

## Your Donations Change Lives

We paid two months rent for a senior couple who had been in a very serious car accident, leaving both in comas, one for one month, the other for one week. The driver at fault had no insurance. Their share of hospital bills (20%) exceeded \$200,000. They paid what they could and were working with the hospital on a repayment plan, but were facing eviction.

A Post Office employee suffered kidney failure and required multiple dialysis treatments each week. His wife had been laid off as had their two sons who moved back home with their parents. The wife and one son found new jobs, and the family needed help with their mortgage until they received wages from the new jobs and disability benefits. As with many of our clients with serious illnesses, the husband was denied disability benefits. Though he will eventually receive them, appeals may take up to four months.

A father of two lost his administrative job when Mervyn's closed. His wife lost her managerial position when Circuit City closed. Unemployment benefits were far short of the couple's monthly bills. SCS paid their mortgage. Their families had been helping with bills for several months. Both found new jobs which paid less than their previous positions, but just enough for them "to squeak by."

After many years of physical abuse, a wife decided to leave her husband when he threatened their children. She came to SCS for help, and we convinced her to go to the Support Network for Battered Women where she received shelter, legal assistance, and counseling. When it was time for her to leave the shelter, she came back to SCS. As with many of our clients, she could afford the rent for a small apartment and other monthly bills, but she didn't have enough for the deposit. SCS paid it.

## AT A LOSS FOR WORDS

Last month, a good friend called me to comment on the front page article in the April 14th San Jose Mercury News about the level of need we are seeing at Sunnyvale Community Services and our search for the words to describe it. The first sentence read, "Nancy Tivol has run out of words." Knowing me very well, she said, "Things must really be bad if you are at a loss for words." They are.

Families that came three or four months a year for food now come every month. Everyday, many new clients come for financial assistance. We continue to see an alarming increase in the number of seniors seeking our help, many of whom came only because a friend or neighbor convinced them that there is nothing wrong in asking for the help they so desperately need. Before the end of the third quarter of this fiscal year, we spent more on financial aid, distributed more food, and helped more people than we did during the entire year before. And at that time, we had helped only a handful of middle class families who, after losing their jobs, had gone through their savings and help from family and friends.

How have we been able to keep up?

- Focusing on the basics. As client numbers started to skyrocket, the Board of Directors, through its strategic planning process, focused all resources, human and financial, on the two most critically needed services—financial aid and food.
- Keeping overhead low (10% last year). Over 250 volunteers a year staff our front office and run our food programs. Over 600 run the Community Christmas Center. Annual volunteer hours equal those of 11 full-time staff; we employ 7 full-time staff.
- Retaining key support. We have been able to retain support from major corporate, foundation, and government funders over the years because of highest possible performance ratings and sound fiscal management.
- Keeping a great "veteran" staff. Virtually no staff turnover eliminates the time and expense of hiring and training employees and results in a knowledgeable staff that provides quality service. Our 7 full-time staff members have a combined 92 years at SCS (and the newest member hired two years ago replaced a 17-year employee).

But most important, the majority of our funding comes from our local community. Your support simply means more help available for low-income families and seniors in Sunnyvale. And without layers of bureaucracy, we can provide that help as soon as we can verify the required information, usually on the spot or within several hours.

We ask that you consider a tax-deductible donation to SCS, and if you usually donate in the fall, that you consider another donation now. Our clients have never needed your support more.
