— Working to Prevent Homelessness and Hunger —

We are All Part of the Safety Net

On Friday, April 15th of this year, we learned about the kind of community we have in Sunnyvale. That day, there was a three-alarm fire at the Twin Pines Manor Apartment complex. Our City's Public Safety Officers immediately worked to save everyone's life. The American Red Cross and City of Sunnyvale staff set up a temporary shelter at the Senior Center. But it soon became clear that the entire complex was declared unsafe, and 169 people became homeless.

Just three days after the fire, Sunnyvale Community Services took over case management for all of the families. We soon realized that 80% of the families earned low- to extremely low-incomes, and now they had lost their homes, and for many, all of their belongings.

Teamwork & Hard Work

Helping 70 families rebuild their lives was going to take tremendous resources. Funding from our City, our County, The Housing Trust, dozens of corporations, and hundreds of individuals flowed in to help the families. Local hotels gave discounted rates, nonprofits stepped up with transitional housing units, and dozens of landlords eased their lease requirements for fire victims.



Every part of our agency was tapped to help the fire victims, but we also had to keep our doors open for others in need of assistance. Monday morning was also "business as usual," with our morning delivery of fresh produce from Second Harvest Food Bank, ready to be bagged and distributed to the 900 families who come every week for healthy food they otherwise cannot afford.

Dedicated SCS staff quickly outlined special procedures to help the Twin Pines Manor residents, and partner agencies including Downtown Streets Team, CSA Mountain View, and West Valley Community Services assigned staff to work alongside of SCS.

We are happy to report that all of the 70 families have moved into permanent housing. Thanks to helpful, compassionate landlords, half of the families have been able to stay in Sunnyvale.

The Twin Pines Manor fire was an unprecedented emergency for our community. But, in September we were faced with another emergency when an apartment fire on Gail Avenue left 46 people with no place to stay. Again, many of these families are low-income without the resources to easily start over. SCS is working closely with these fire victims, just as we did with the Twin Pines Manor fire victims. Outside of these "events," every day families and seniors come to our door. They face financial emergencies as well as year-round food insecurity. Living on the edge, low-income families and seniors are one bill away from homelessness.

Sunnyvale has been described as a "big little town" where everyone is connected. Public officials, City staff, nonprofit partners, service clubs, faith communities, and many individuals all work together, making Sunnyvale truly the "Heart" of Silicon Valley. ■

President's Corner

Execution Excellence... what does it truly mean when an organization executes with "excellence?"

Execution excellence is not an innate behavior and isn't something that just happens. It's a learned skill that develops through hours or even years of training.

Take marathon running. We're all familiar with ads pushing high performance running shoes. It's true that a good pair of running shoes can enhance performance, but alone, they don't make an endurance runner.

Lacing up the shoes is the first step and going the distance requires a lot of hard work, dedication, agility, and a love of running. Over time running just becomes habit. In marathon running the goal is usually to set a personal record or PR. A runner feels when they are going to PR because each step and breath is in perfect harmony.

Now, apply this to an organization. One that is executing flawlessly is an agile system of finely trained individuals focused on reaching a PR. Execution excellence is their constant state—a habit. In April, SCS ran a marathon. The Twin Pines Manor Apartment fire left 169 low-income residents homeless. SCS was quickly on the scene and took responsibility for case managing all of the fire victims, while at the same time continuing its daily operations without skipping a beat. In other words, the entire SCS team laced up their running shoes, ran the distance as a team, and set a new PR for the agency and the community.

Execution excellence at SCS would not be possible without the support of its donors and volunteers. Every day SCS ensures that the agency can go the distance by carefully allocating volunteer time and financial donations to those projects that further strengthen Sunnyvale—enabling the community to go the distance and reach a new PR. ■

Weekend School Food Program

According to a study done by the Lucile Packard Foundation for Children's Health, 17.2% of children in Santa Clara County live in food insecure households; 37.8% of children in the county qualify for free or reduced price lunch. In partnership with Second Harvest Food Bank, Sunnyvale Community Services is now providing weekend food for over 400 families at four Title I elementary schools in Sunnyvale: Bishop, Lakewood, San Miguel, and Vargas Elementary Schools. Every other Thursday and Friday, each family takes home 25-30 pounds of nutritious, kid-friendly food for the weekend, including eggs, cheese, fruits, and vegetables. We are proud to partner with these schools to help families close the hunger gap. ■

Did You Know?

Last April, the Sunnyvale City Council adopted an ordinance to increase the City's minimum wage to reach \$15.00 per hour by 2018.

Implementation Schedule

July 1, 2016.....	\$11.00
January 1, 2017.....	\$13.00
January 1, 2018.....	\$15.00

How this helps

75% of SCS clients are the working poor, living paycheck to paycheck. The increase to \$13/hour in January can mean the difference between being housed or homeless for families and their children. Most of our clients work multiple part-time jobs without benefits. When we calculate a family's budget for financial aid, we often include wages from working teens making minimum wage—families need every dollar to pay rent and make it through the month. The increase in the minimum wage will help more families to be self-sufficient.

Please support our local businesses and restaurants who are paying their workers the new minimum wage.

Cold Weather Shelter has Permanent Sunnyvale Home

The Cold Weather Shelter will operate at a new facility owned by the County at 999 Hamlin Court in north Sunnyvale, near the intersection of Mathilda and Ross Avenues. The Shelter will be open from Monday, November 28th through Friday, March 31st and can accommodate up to 125 individuals. All beds will be reserved, and SCS is one of the primary referral agencies. Last year, we referred and case managed over 50 individuals staying at the Shelter, helping many of them progress to stable housing and self-sufficiency. ■



Saturday Pantry

Many of our clients work full-time or work two jobs and have a hard time making it to SCS during the week to pick up their food. Starting in June 2016, we opened our pantry program every 1st and 3rd Saturday morning for those clients who cannot make it during the week, often due to lack of transportation and/or childcare obstacles. During June, July, and August we served 855 clients who told us how helpful it is to have a weekend pantry day. The Saturday program was so popular over the summer that we are continuing it throughout the year so that our clients have more options to get the support they need. ■

Bringing Help to Our Neighbors in Alviso

SCS is coming to Alviso! Sunnyvale Community Services is one of seven agencies that are part of the Emergency Assistance Network (EAN) covering all of Santa Clara County. After a close look at underserved areas in Santa Clara County, SCS has extended our services starting in September to our neighbors next door in the Alviso zip code 95002, population of 2,000. Because of the neighborhood's location, it has been difficult for low-income residents to access safety net services in the past. SCS has been fortunate to already have tremendous support from the Alviso community. We have partnered with Alviso service providers who have distributed SCS information to residents. Free office space is provided twice a week at Gardner Family Health Center to serve as an SCS satellite office for easy access to services. Eligible Alviso residents will have access to SCS financial assistance thanks to County-wide funding to assist families and individuals facing a temporary crisis. We hope in the near future to extend the full range of our services to the Alviso neighborhood. ■

Neighbors in Need

● A Veteran Suddenly Homeless

For 20 years, our client, who is a veteran, was an on-site property manager at a Sunnyvale apartment complex, until one day, unexpectedly, he was let go. With no place to go, his car became his shelter. Since he was older, the experience of being homeless led to health problems, further exacerbating a very difficult situation. It was hard for him to ask for help, but fortunately SCS was able to help him complete affordable housing applications, resulting in finding a low-income unit in a senior living community near a hospital. This very grateful client was able to move in with a new bed and dresser, provided by SCS, and get access to the healthcare he urgently needed. ■

● When Life Changes in an Instant

On an otherwise nondescript day last April, a Twin Pines Manor fire victim lost her home and all of her belongings in an instant. The tragedy escalated from there when she began to miss a lot of work while searching for a new place to live. The loss of income, combined with a very competitive and expensive housing market, put her at risk of homelessness when the temporary motel assistance expired, something she deeply feared. Sunnyvale Community Services was able to step in quickly and assist her not only with extended temporary housing, but also with finding a permanent new home. When the client moved into her new Sunnyvale apartment, she literally had nothing. Fortunately SCS was also able to provide basic furnishings and household items to help her get a fresh start. ■

● A Mother's Love

The Twin Pines Manor apartment fire wreaked havoc on so many Sunnyvale families, but one fire victim wasn't going to let that get in the way of her youngest son's education. He had been accepted into Fremont High's distinguished Avid Program and his mother didn't want their sudden displacement to get in the way of her son's opportunity. The Housing Case Manager at SCS made it her mission to find affordable housing within the Fremont High School district and was lucky enough to meet a landlord who had been wanting to assist the fire victims. He waived the application fee and lowered the rent, and SCS assisted with the security deposit, so that this family could afford to live in this freshly remodeled apartment unit. The son is now off to school and the client is overwhelmed with gratitude for this second chance. ■
